

Dear Gentles and Gentle Cousins

The next three articles discuss an issue currently occupying the attention of some persons in Storvik, to wit, what to do about certain administrative problems we are encountering because of our very size. These articles are not meant to create a you versus me atmosphere - they were written to provide you with information and perspective concerning the discussion now enjoined about the future of Storvik. B of W.

A Very Brief History of SCA Boundaries in Greater Washington, DC

-- Ysabeau Cameron of Lochiel, founding Baroness Storvik

When I first joined the SCA in the spring of 1973, there was no group in greater Washington. The Barony of Merkewood was the nearest group, and everything south of Baltimore was wilderness. But things were starting to come to life; later that year Alyson of Islay -- who lived on the very edge of the world, in Reston -- became Queen of the East. During 1973-75 there were several unsuccessful attempts to start groups in Northern Virginia and DC.

At that time we gave very little thought to the possibility of a single group [shire or barony] for all of greater Washington. First, by ancient custom Myrcwud laid claim to all of Maryland. Second, SCA Inc. was opposed to groups crossing state lines, since it could overcomplicate tax reporting.

In 1975-6 three separate shires were started -- Torhvassir in DC, Caer Cladach in the Maryland suburbs, and Aster in northern Virginia. At that time ZIP codes were not the standard means for defining group boundaries. Torhvassir was defined as the District of Columbia; Caer Cladach was the 5 southern counties of Maryland [we only cared about Montgomery and Prince George's, and took the other three to simplify the border with Mirchud]; and Aster was the DC suburbs of Northern Virginia [which wasn't a problem then, since there was virtually nobody between DC and Richmond].

All the shires were fully staffed and functional, and Aster and Torhvassir at least were holding events. But there was so much crossover attendance, and so much need for mutual support, that we wanted some structure to act as an umbrella for the whole greater Washington area.

At that time, Corpora had provisions for a peculiar group known as a "charter barony." This sort of group functioned in essence like a super-household: it was a voluntary banding-together of people with common interests, and owned no territory. During 1976 the people of all three shires worked out a structure for a charter barony to support the interests of SCA members in greater Washington. At the Eastern Fall Coronation in 1976, Alaric and Yseult signed the charter for the Charter Barony of Storvik.

For the first three years of Storvik's existence, the shires continued to be the official territorial groups; they had officers and held events. The Charter Barony also had a slate of officers and held its own events, and continually begged for members, since charter baronies had a higher membership requirement than territorial baronies or shires.

In the Maryland suburbs, Caer Cladach had trouble working out its relations with both Mrquud and Markland; this was especially delicate because the rest of Maryland didn't want to join the new Principality of Atlantia. In early 1977, Caer Cladach was reorganized to accommodate both SCA political issues and the needs of crossover groups like Cambion, and renamed the shire of Seagate.

By the end of 1979, the Corporation's position on crossing state lines had eased, and we were able to persuade the Kingdom and Board to permit a territorial barony to be formed in the territory occupied by the three shires, making the shires into cantons. Seagate dissolved almost instantly and Aster after a few months, and Torhvassir has continued on and off ever since, most recently attempting to reformulate itself as a college.

As you can see, the group definitions and boundaries of the greater Washington area have always been fluid. We've been able to form them to our needs of the hour -- first as a tiny, undifferentiated part of Murcwode; then as individual shires; then as shires united under a charter barony; then as a territorial barony with cantons; and most recently as a territorial barony with a would-be college. Our tradition goes back much farther than the present arrangement, and we have always found new structures when we have needed them to serve our evolving situation.

Baroness Elaina sends greetings unto the populace of the Barony of Storvik.

Gentle Friends,

At the last two Barony meetings we have discussed Storvik's growing need for a more diverse administrative structure. At the March Barony meeting it was suggested that someone write a letter for publication in the Drekkar outlining why we feel action needs to be taken and what we want to do.

The "why" is simple. Storvik has become too large to be administered effectively by the officers she has. I was astounded to find, in the latest membership list form Corporate, that Storvik lists 256 members. We run four to six fighting practices a week and are only allowed two warranted marshals to supervise them. Our exchequer must keep the books, make the deposits, and write the checks for approximately fifteen events a year, making her in effect the deputy autocrat for every event in Storvik. We need to expand our base of officers and administrators to handle this load.

How do we do it? The simplest method is to divide the Barony geographically into four cantons. I suggest the following division:

- -- Northern Prince Georges County
- -- Southern Prince Georges County & Charles County
- -- Montgomery County & the District of Columbia
- -- Alexandria, Arlington & Fairfax Counties

At the April Barony meeting we will have a large, mounted map of the mundane Storvik area marked with pins to represent our population distribution. At that time we can determine if the suggested canton boundaries truly reflect our population.

In closing, I would like to emphasize that this proposed division into cantons is administrative. We need more officers to carry the workload. The Barony of Storvik will continue as it has for the past ten years. I want to say how deeply pleased I was at the March Barony meeting to hear such a large and diverse group of people speak about their commitment to Storvik. It reaffirmed my own

> A MISSIVE ON THE MERITS OF THE DIVISION OF THE BARONY

Good Gentles, it has fallen to myself to bring before you the case in favor of dividing the barony into two baronies. To do this I must go over, in brief, why the status quo is no longer the best choice. The problems that face the barony are based in the fact that the barony covers too many people. The lack of marshals and the strain on the Exchequer to provide service for so many events. A strong case could be made that sub-dividing the Barony will cure the former ill, but not the latter. In fact, sub-division will not only aggravate the exchequer problem, but bring along problems of it's own. Consider if five Cantons are created, each baronial officer will have between zero and five subordinate officers. This will add to everyone's workload and will subtract from none. The exchequer will be the hardest hit of all, unless the Barony divides up the treasury amongst the cantons, for she will not only be responsible for same funds as before, she will also have to audit the books of each canton because she will be responsible for their money also. Splitting the Barony has the advantage of halving the responsibility by doubling the staff. It allows the twin baronies more chance to be reachable to the individual. Growth, energy, and expansion could occur by creating more opportunities. There are hazards, most notably sibling rivalry, but none that are insurmountable. handled correctly, such a division could allow us to have two strong baronies, capable of creating things one barony, however large, could hope to achieve. One should look to our cooperations with Lochmere as an example. Traditions from the past should not blind us to the needs of the present, or to the dreams of the future. In Service To the Barony,

A Letter Concerning the Office of the Drakkar Prusuivant

Unto The Populous of the Barony, Laird Donal Galbraith, Drakkar Pursuivant, Sends Greetings!

My Lords and Ladies,

Having decided that the time has come to relinquish my office as Herald of Storvik, I feel I must explain the duties that come with the office. There are three major duties that need to be performed, all equal in importance. A gentle wishing this office should consider how they would perform in all three. The most public of these is the duties of court heraldry. Being the voice of the Baron or Baroness is the most physically trying of your duties. A herald without the ability to make himself heard during court would not only hurt the Barony, but themselves as well. The duties that will be the most time-consuming will be those of what is called "Book" heraldry. Paperwork will become a large part of your life. If there is a Cantonization of the Barony in the future, the paper will only increase. The submitting of devices and names is the job with the longest lasting effect of all your duties. People remember the heralds that got them the devices they wanted, and those that said no. The last of the three is your duties as a great officer of the Barony. A gentle who dislikes barony meetings is not a person who wants to be herald, as you will go to a lot of them. As herald, you are second only to the seneschal in office seniority. In the event the seneschal is not able, the herald is next in line. This usually means you will have to run the occasional meeting, at worst, you could end up acting seneschal. Not a very likely event, but one to be given some thought. These are the major duties of the Herald of Storvik, the gentle I will recommend to their Excellencies would be he or she that has capability in all three duties. In service to the Barony, I remain,

Unto the Good Gentles of this Land, I, Jean Charles d'Avignon, Lord of the Isle of Roos, Squire, Captain of the Companie of Saint Sebastianne, do send my greetings.

As many of you have heard, I have recently set out upon a new venture, the construction of a new castle which is both more spacious and better for the defense of my small lands. So it was last week that in my efforts to move myself, I did come upon a collection of letters of one of my ancestors, the fine Lord Scrivener Edward d'Avignon, who has preceded me in this land by exactly two hundreds of years. Having read already dozens of his letters, I have learned many a fine lesson upon our history, which, accurately it seems, is recalled for me in his letters to his Lady, the fair Elise Lorraine de Tours, and to his brother, the Monk Guy d'Aix.

Thus, after good discussion with my Lord the Baron and his Lady the Baroness, I have determined that it would be to our mutual advantage that I would publish some of these things, without commentary (whenever I may restrain myself), and only the barest editorial glance.

Before I continue, I must offer a slight explanation. My late Lord Edward d'Avignon did accompany a Crusade with first the King Friderick, then with the Lord Conrad de Montserrat, and finally, did take up with the English King, Richard. This was the greatest of mixed ventures of his day. Beset by peril, he nonetheless returned to his lands outside of Aigues-Mortes and, having survived his venture, never set out again upon Crusade.

So I am pleased to introduce to you the first of the letters, as received by Guy D'Aix, from Lord Scrivenor Edward d'Avignon.

The letter of Edward d'Avignon begins on page 23

My Dearest Brother, Guy d'Aix, on this day, the 29th of March, in this year of 1190, I, Edward D'Avignon, write from the shores of Anatolia, in the land of Byzantium.

My excitement reached its peak as I set foot upon the rocky beach of Gallipolus, for our great army had achieved the crossing of these terrible straits with only the slightest of peril. A light wind here comes in from the sea and a strong current confounded many who tried to build rafts for the efforts. Yet finally, we were all across in safety. As I looked up the grassy beach, I felt a strange familiarity with this place. On the heights above us, there were trees that I saw, fine stout foresting that reminded me of Sicily.

As far as the eye could see, there were no Turks or Byzantines barring our path, and so we took our leisure in preparing ourselves for the march inland. There we camped, upon the beaches and on the heights, and for the whole of yesterday we arranged our van for the long journey ahead.

All the while, our King, Friderick Barbarossa, passed amongst us, offering his encouragements. As I looked upon our army, I saw that it was a great sight to behold, all of the shining helms, the good German swords, and great chargers, with many stout men-at-arms, and the finest of dukes and earls of Germany. Indeed, our numbers are certain to be in excess of 40,000 good men.

The spirit of our army was so high yesterday that no Turkish force, no matter its size, could have but skirmished with a foraging party before meeting their doom. Friderick, for his part, did nothing to dissuade us, and he allowed his son and namesake, the Duke of Swabia, to partake with us of the fruits of celebration, with fine wine from a nearby Byzantine village.

Word has reached our army that the King of England, Richard, was crowned King upon the third of September in this last year and is eagerly preparing to join us in Crusade, together with the King of France, Philip Augustus. His father, the poor late King Henry, though fallen ill and unable to fulfill his own vow to Crusade, did make his peace at last with the King of France, before ending his days at the Castle Chinon. And King Richard now seems pleased to join with King Philip Augustus, with whom he had fought against his late father. All shall now make haste to Outremer to save Jerusalem from the infidel. The rest of the world does follow in our King's footsteps.

England seems to have raised a tax termed the Saladin Tithe, which, though burdensome, has caused every faithful hearth to offer up the most for the good King's venture. I would ask you that you would, in administering my lands, institute such a tax in my maintenance, so that, if affairs are not to my liking, I may have the necessary support to return home without delay.

You may be interested to know that during King Richard's absence, he has granted powers to the Queen Mother Eleanor and to William Longchamp, who is Bishop of Ely, and Hugh, Bishop of Durham, who you perhaps recall from our visit to Ile-de-France four years ago. He did grant them chancellries and justiciaries to assure the safety of his realm. On my account, I ask that you would establish contact with them to further assure my support. I can only conclude that such is a smart King, this Richard, who, unlike our great and royal King Friderick, has not the power of presence as yet to assure his own throne in his absence.

Upon the first of April, the King of France, Philip Augustus, has declared that he shall meet with Richard, King of England, at Vezelay, to discuss plans for their great departure. While Vezelay is a distance from you, I would ask that you send our seneschal, Carlos Aragonne, north to attend the events. I am greatly hungry for the news of their plans.


So that you may know of the tidings from St. Jean d'Acre, that beautiful port city upon the shores of Outremer, I must write that the King of Jerusalem, Guy Lusignan, has mustered the last 200 knights of Tripoli to lay siege to that once fair city, now captured by the infidel. The walls are so vast and the enemy so strong that now the King's siege men are themselves besieged in the hills surrounding the city and have dug trenchworks and built barricades to assure their own safety. And Saladin, ever desiring to slay more of us, has entirely encircled them and is assuring them of their imminent destruction.

There, as a messenger yesterday told our King, when the army was so much as ready to all perish, James, Lord of Avesnes, the greatest knight of Flanders, arrived off the coast of Syria with a fleet of Danish and Flemish ships. He has set about blockading the port, but we do not yet hear that he has raised the siege there.

Despite this greatest gesture, it appears to me that such folly has begot King Guy that he may have considered victory over Saladin with but 200 knights against their army. Already the infidel, whose numbers are so vast that the fields are covered black with them, has defeated Jerusalem, Tiberias, Ascalon, Jaffa, and many fine tall castles of the great Papal Orders of the Templars and Hospitallers.

Our King Friderick, on hearing this news, appears pleased, for despite this audacious ploy, surely King Guy shall not invest his seat in Jerusalem before finding death in the field. Perhaps if King Friderick were to inherit the title of Jerusalem, the poor man who is King Guy would no longer entertain the Saracens with his gestes of battle. Then the land would be safe from the infidel.

We march now for Laodicea and Myriocephalum, which are Byzantine cities, and they have offered us fine passage through their lands. I shall write again from the gates of those cities.

On the Ordering of Rank and Precedence in Atlantia Ysabeau Cameron

Being the second portion of the missive.

Now shall I pass on to the second estate of Atlantia, that of the Patent Orders. And in this shall be seen that Atlantia is the flower of the Known World. For know you that there are four Patent Orders recognized in Atlantia, namely the Chivalry, the Laurel, the Pelican, and the Rose. And whereas the Royal Peerages are arranged in strict order, with the Ducal rank the highest of them, yet are the Patent Orders all coequal, with no one in precedence over the others, and thus are all their members called Peers. For each Peer must have distinguished himself or herself in the noble virtues, as courtesy, honor, hospitality, and respect to the Crown, and the courtly attainments, as letters, dance, music, heraldry, and chess. And these Orders are named the "Patent" Orders forasmuch as every member thereof receives a Patent of Arms, which is the highest of the classes of Arms. And the fellowships of these Orders are as follows:

The Chivalry is in its turn made up of two Orders, these being the Knights, and the Masters and Mistresses at Arms both these Orders being made up of folk who have mightily distinguished themselves on the field of combat. The Knights have sworn fealty to the Crown of Atlantia, whereas the Masters and Mistresses at Arms, for their own privy reasons, have been constrained so not to do. The Chivalry may be known by their accoutrements, namely: for the Knights, the chain of fealty, the white belt, and the spurs; for the Masters and Mistresses at Arms, the white baldric and the spurs. And it is for this reason that the wearing of plain golden chains, white belts and

baldrics, and spurs, is forbidden to all who are not members of this Order. Knights are both entitled and addressed "Sir" [although it is said that in some foreign realms, ladies who are Knights have chosen to use other titles and addresses which are unknown among us in Atlantia], and Masters and Mistresses at Arms are likewise both entitled and addressed "Master" or "Mistress." And it is the privilege of the Chivalry to take Squires, which are folk who bind themselves to their tutelage in matters martial.

The members of the Order of the Laurel are honored above all others for their notable accomplishments in the Arts and Sciences which so greatly enrich our Society and bring such pleasure to all its people. These folk are permitted to wear about them the emblem of their noble Order, which is the wreath of laurel. And consider how greatly they are esteemed among us, that they alone are permitted for their emblem the very sign of our Society! The members of this Order are both entitled and addressed "Master" or "Mistress." And it is the right of the Laurels to take Apprentices, which are folk who bind themselves to their tutelage in matters of the Arts and Sciences.

The members of the Order of the Pelican are especially honored for the great service which they have done, and do, for Atlantia and for the advancement and continuation of our Society. They alone are permitted to wear about them the emblem of their esteemed Order, which is the Pelican in her piety, rending her breast to feed her young upon her own heart's blood. The members of this Order are both entitled and addressed "Master" or "Mistress." And it is the pleasure of the Pelicans to take Proteges, which are folk who bind themselves to their tutelage to learn the ways of service to our fair Kingdom and Society.

The Order of the Rose is composed of those folk who have served as Consort to a Kingdom. In Atlantia at this time, all such folk are ladies, and so therefore this Order is often spoken of as "the Ladies of the Rose." And it may be seen that all the members of this Order are likewise members of the Royal Peerage. They have the particular emblem of a wreath of roses, which only they may put upon their devices, although many individual members may elect to wear or display roses about their persons. Likewise they have no peculiar title or address, but each member is entitled and addressed according to her rank, that is, as a Duchess or Countess. It is said

that in some lands the Order of the Rose is not counted among the Patent Orders; but such is the esteem in which Atlantia holds these ladies that they are accorded this honor. And this Order, alone among the Patent Orders, takes no one into tutelage.

And even as within the Royal Peerage one person may be possessed of more than one title, so within the Patent Orders one Peer may be a member of more than one, as a Lady of the Rose who is likewise a Knight; or a Master of the Laurel who is also a Master of the Pelican; and so forth. But such folk, though greatly to be honored, do not rank beyond those of their fellows who are members only of one Patent Order; for they are all peers.

Third among the estates of Atlantia are the Landed Baronage. And these folk alone hold land of the Crown, and do homage therefor; and they stand as the representatives of the Crown to the folk of their Baronies. Thus it may be seen that alone among all the estates of Atlantia are the Knights and the Barons required to swear fealty to their Crown, although any person may do so of his or her own will. Understand as well that, out of the great gratitude which the realm bears unto those who first established and brought forth each of the gracious Baronies which so nobly adorn this fair Kingdom, that such folk as may have departed the estate of Landed Baron or Baroness, if it so be that they were the first, or founding, Baron or Baroness of that place, then their names are permitted to remain on the Rolls of Precedence among the Landed Baronage, and they may ever thereafter style themselves "Founding Baron" or "Founding Baroness," adding thereto the name of the Barony of their founding. The dignity of the Landed Baronage conveys with it possession of a Grant of Arms and upon leaving that estate, one still possess the said Grant of Arms. And these folk are entitled "Baron" or "Baroness," as might well be thought; and they are addressed "Your Excellency," "My Lord Baron," or "My Lady Baroness."

Now, this next estate of which I shall treat, the Kingdom Orders of High Merit, is one which is never created in Atlantia; yet it is created in some of our sister Kingdoms, and out of gracious love for those lands and their peoples, Atlantia is ever eager to recognize and honor those folk who have been valued by other Crowns. These Orders convey with them a Grant of Arms, the which no Atlantian Orders or awards may do; and accordingly they are in precedence before the Atlantian Orders of Merit. But they convey neither titles

nor styles of address, and their holders are properly addressed "My Lord" or "My Lady." Fifth among the estates of Atlantia stand the Grants of Arms, for while no Atlantian Orders may convey such a Grant, yet in their puissance our Rulers may well bestow a Grant of Arms upon such of their subjects as they shall deem worthy so to be honored. In Atlantia, such Grants are commonly given to folk who have departed the estate of the Landed Baronage, and who were not the Founders of their Baronies, that they may know how highly they are prized by their Kingdom, and may stand in precedence only one step behind those of their erst fellows who yet enjoy the Grants of Arms conveyed by their Baronages. And the holders of Grants of Arms are properly addressed as "My Lord" or "My Lady."

Chivalry and the Viking or Always Clean Up After You Pillage

> One Man's Observations by Lord Torvald Hrajnsson

When people are asked to think of the Middle Ages, they often draw a mental picture of a French or English knight, standing in polished 16th-century plate mail. This paragon of chivalry would probably be protecting some beautiful maiden or sparing a dread foe after vanquishing him single handedly on the field of battle. Few would think of the proud Viking, standing at the prow of his speeding drekkar as it glides over the waves, heading for distant and unknown lands. Some would argue that the image of the knight and his courtly love was the flower of medieval idealism and should be the model for the perfect Middle Ages. I contend, however, that the Viking has a right to equal status.

A discussion of the Vikings as a great trading people, traveling to parts of the world thought to be mythical by most other Europeans, and living in an artistic culture, would be redundant to many. They were not a single nation, but an independent people who were

used to "living" in the short summers between seasons of ice and snow. to compare them to the noble knight, loyal vassal to the king, might be a little more interesting. It is, at least, an easy way to get into trouble.

The Vikings of the Middle Ages did have a violent nature. That they lived a hard and somewhat fatalistic life has been demonstrated over and over, sometimes at the wrong end of a broadsword. It was probably thought to be a gift from the gods that the peoples of the western lands kept their valuable treasures in strongholds so poorly defended. The Christians called them monasteries, I believe. The Vikings, without much coaxing, took full advantage of northern Europe's abundance, not only bringing hope large quantities of booty, but settling in these warmer climes whenever possible. Good land was valuable, but they couldn't take it home like gold or silver.

But they are still bloodthirsty, axe-wielding marauders, you say. They did indeed travel vast distances and used the battle axe to good effect when necessary. But as for being 'bloodthirsty'... with whom are these men of the north being compared? The meed and gentle Saxons? The peace loving Franks? History seems to have been written almost solely by those on the receiving end of Viking exuberance. Hardly an objective viewpoint.

What then of the noble knight, clad in his shining armor and wrapped in a cloak of chivalry? It would seem that in rereading history, the armor becomes a bit dulled and the cloak a little tattered and frayed. The true nature of war had little use for honor and mercy. Either the outnumbering and mutilation of an opponent (ex. Simon de Montfort), or the looting of a town too near the marching feet of an army would shatter most illusions of the chivalrous knight. That they existed should not be denied – but that they were a common occurrence throughout the Middle Ages seems very much in doubt. To me, the grand picture being held up in comparison to the Vikings is not without its own blemishes and flaws.

The laws of chivalry were, and still are, a noble ideal that all good gentles can aspire to. I try to measure up to them myself. The fact

that greed, revenge, and politics were often more powerful forces in the past should in no way diminish the honor inherent in the status of knighthood. It would be unjust (as well as fatal) not to differentiate between the lofty goals of chivalry and the unfortunate lapses. So it seems it is the ideal that we should be concentrating on. Given that we in the SCA want most to emulate the high ideals of the Middle Ages, and not necessarily the realities, what light does that shed on the Vikings? While dying in battle was seen as a sure way into Valhalla, it was meant to be in combat against an armed opponent, against great odds, or some other heroic action. The crueler aspects fo warfare did not demonstrate a man's bravery and were disdained as in later times. Much of the Eddic poetry and the sagas of the age glorify the mighty warrior and hero, just as the tales of the Round Table hold the ideals of chivalry aloft.

Regardless of their drawbacks, there is a point of view concerned with whether we, the society, should be considering the Vikings at all. There is no place for them with in the feudal system of Christian knights and vassals. Often, they could only be brought together by brute force (such as Harald Fairhair's uniting of Norway), and although Christianity was eventually recognized as the true faith, pagan beliefs lived on side by side for generations after. Still, they did have a profound and lasting impact on early medieval Europe. The existence and exploits of the Normans is but one example A people who had such an influence must be taken into account.

If we are to ignore the brutal realities of the past while constructing our modern Middle Ages, then pointing out all the undesirable aspects of the Vikings, however numerous, is using a double standard. For those who strive for authenticity and are dubious of a 10th-century Viking talking with a 14th -century French nobleman, consider this: We may not want to recreate the conditions of the Black Death, so the Viking may be though of as a fair substitution. A historically important phenomena, common to many countries, but without all those nasty blotches.

By the way, does anyone know the way to Lindisfarne?

Three gentles, Master Igor Bear, Lord John of Dundas and Lord Sean MacKay have expressed interest. The MARSHAL sent greetings through the Rapier Marshal. All is O.K. -Sunday practices from now till Pennsic will be devoted to war practice. The Grand Army of the Potomac is to be resurrected. Rapier practice will also be held on Sunday's at Pimmit. It is requested that black soled shoes not be worn at the Monday practice. House Greygoose wants to hold a regular "new fighter orientation." For information, contact Rorik (301/ICE-LORD). The problem about the shortage of marshals was raised. It was pointed out that only Knights who apply to the Knight Marshal will receive warrants as marshals. The LISTS office reported that she had a new deputy, Mistress Elizabeth Beaufort. The ARTS & SCIENCES Officer reported that the arts (and sciences) are running rampant in Storvik. Lady Elien and Lord Stanford ran the arts table at Coronation. The A&S Officer now has two deputies - Lady Ealasiad Ramsey of Skye for south of the Potomac, and Countess Alyson of Islay for north of the river. The Exchequer was not present. The CHRONICLER reported that the Hats Pamphlet had been published with-out promised corrections and would be revised prior to rerelease.
