
Directions to Hotel:

But all then knew in their own hearts That this was Love he weilded, One by one, opponents came, One by one, each yielded.


None would stand against this man They left the field in shame, For they had met a Champion Who'd fought for Honor's name.



From the hotel to the site—Turn left out of the hotel onto Brook Rd. Go 3 blocks to Westbrook Ave turn right. Follow Westbrook to the end of the road (about 4 blocks); at the light (a T intersection) take a left. The building is immediately on the right hand side of Hermitage Rd (a divided highway).

To the site itself—Take I-95 South to Exit 82 (Hwy 301). Follow 301 until you get to Westbrook Ave (2nd light). Turn right and follow directions above.
