## Hallgerd and Berg-thora:

Women, Law, and Justice in Viking Age Scandinavia Lady Beatrix Von Leipzig

It is a common assertion that women during the Viking age in Scandinavia wielded a great deal of power. Examples often cited are women's control of the keys, their key roles in pagan religious rituals, and the ability of a woman to divorce her husband. This culture is often claimed as a bastion of modern attitudes about women in a time when women were systematically oppressed, but in the legal realm,

the Scandinavian people were no more modern in their views of women than other European countries. The laws of Viking age Scandinavian people were not written down at the time, but the evidence we do have comes from the Sagas, and the earliest written laws from the Gulathing and the Frostathing. While women performed important duties in the home, such as managing staff, healing, and keeping the keys to the storeroom, in the legal sphere, women were second class citizens who could seldom wield legal power except through the men who represented them.

The system of law practiced by the Vikings was rarely enforced anywhere but at the Thing. The Thing is a gathering of freemen occurring usually one to three times per year where all legal transactions took place. Criminal charges were put forth, marriages and divorces were arranged, and any other legal disputes were settled. There was no legal way to handle justice between Things and justice was a matter of personal arrangements between men. William Ian Miller in his book, Bloodtaking and Peacemaking wrote, "There was no bureaucracy, no state apparatus that pretended to enforce the laws, nothing beyond the Things themselves" (Miller 21). Attendance at the Thing was crucial to settling any sort of legal issue that could not be settled man to man, but women were not allowed to participate directly in the Thing. Miller writes that "women were under strong social and legal constraint, in matters of right and honor, to act through men" (Miller 329). The way women were able to be active in legal matters was by appointing her husband, son, or one of the other men in her household to represent her (Miller 27). This is a good system when the man is honest and willing, but it must have been

difficult for women to bring charges against someone if the men were unwilling for any reason. In Njal's Saga Hallgerd has a problem with this system, because Gunnar pays atonement for a slave she had killed. She expresses her displeasure, and Gunnar replies that, "she would decide her own actions - 'but I shall decide how the cases are settled." (Njal' Saga 60). Hallgerd was not able to get her way because as a woman she was not able to act within the legal system.

The laws of the Vikings were not written in books, but rather recited by the Lawspeaker. This does not mean that the laws were changeable and fluid. The Lawspeaker was a man elected for a term of three years. He would be consulted in all matters of law and was expected to know every law in detail. The Lawspeaker would recite all the laws once every third Thing, and the most important parts in their entirety, at every Thing. The Lawspeaker was assisted by five others who could help him remember all the parts, but even so, there were many laws for him to memorize (Miller 18). The Lawspeaker recited the laws at the Thing, but if women were not allowed to participate, it is possible that they did not get to hear the laws in full. For example, Bergthora, Njal's wife, is not present at the Thing several times during her rivalry with Hallgerd, Gunnar's wife, who is also not present at the Thing. She has to send messengers to her husband to report crimes committed against her household (Njal's Saga 60). These women use the opportunity when their men are away to enact justice outside of the legal system by sending servants to kill men from each other's household while their husbands are reluctant to







## Storvik Novice Tourney

July 13-15, 2007 Barony of Storvik



This year's Storvik Novice Tourney will take place in the context of a social structure adapted from the forms of the European Middle Ages. These activities "recreate aspects of the life and culture of the landed nobility in Europe prior to 1600 CE." (SCA By-laws) That's right, the theme is 600 to 1600 CE! Since Novice Tourney is about the novices in the Society, we request that all non-novices show up as their persona of choice to give a wide display of what we do.

Martial Activities: Authorizations: Being only two weeks before Pennsic War 36, this is a great time to get authorized. Novices looking to participate in the Tourney, and those seasoned veterans trying out a new weapon style should arrive early, as we expect there are many who will need to be authorized. (Marshalls who are available to help out with authorizations, please e-mail the Autocrat). Heavy Combat: On Saturday there will be a Novice Tournament exclusively for fighters who have been authorized for and practicing heavy combat for less than 365 days. There will also be additional tournaments and some melees. Fighting will finish with War Practice on Sunday. Our site has lots of open field and wooded areas for several different scenarios, some of which will include combat archery. 

*From the South:* Make your best way to the Washington Beltway (I-495/I95) and US-50. Take US-50 toward Annapolis. Take the first exit from US-50 onto MD-704 toward Glenn Dale and Bowie. act as violently as the women wish. Miller cites another instance where "one exceptional woman" (Miller 351) is allows to participate in the settlement of a dispute, but it is clear that this is a rare exception.

Despite their inability to settle disputes directly at the Thing, women could have significant place within her family, there are many women who are the head of a household. Miller also tells us that Women could inherit Chieftainship, although they were not able to discharge the duties. When they inherited the power, women were forced to give it over to a member of the local Thing (Miller 24). This gives women a great deal of power to choose who will be the leader, but she herself is not able to lead. This may relate to the Thingman/Chieftain bond, which was an agreement between a chief and a member of the Thing to work together and be allies. The Thingman gave his loyalty to the Chief in return for favors. This was a fluid system in which Thingmen could change Chiefs if they were unhappy. A woman could not participate in this type of relationship because it is based on mutual support during legal disputes at the Thing, where women were not allowed to participate.

Despite their lack of power at the Thing, in matters regarding property, Miller asserts, "the Icelandic laws accorded women, both single and married, substantially more rights in property than other Scandinavian or continental codes" (Miller 27). Discussion of women, inheritance and marriage is too extensive to be covered in this essay, but there is an important law regarding women's legal power to make purchases. In Norway's Gulathing Law, for example, women were limited in their purchase power based on the amount of the purchase, and her social status, but her husband could annul that purchase within one month (Gulathing 76). The Gulathing and Frostathing Laws were written after Norway was converted to Christianity, so that may have changed some of the laws. It is clear that this excerpt shows how tenuous women's control over the monetary expenditures of the household was. Overall, making assumptions about all of Scandinavia may not be accurate because the laws were different in different countries.

Unlike purchasing, where women were very much involved, women usually did not directly participate in warfare, but they are mentioned often in the laws in relation to violence. For example, the punishment for murder by a woman was the same as for a man. Further, when a woman was murdered, the wergeld paid was equal to that paid for a man (Gulathing 132). Even though women were usually not allowed to participate in legal disputes, they were empowered to participate when violence erupted among themselves. The law reads, "If [two] women come to blows no man can claim any atonement, only the women themselves [can claim it] (Gulapingslog 141). This indicates a certain amount of independence on the part of the women, because it is not clear whether it was required that a man go to the Thing to represent her.

It becomes clearer when reading the other laws that the person entitled to atonement is the person considered to have been harmed. That being the case, Rape was not considered a crime against a woman, but rather the man who was her guardian.

"In the case of a daughter or a sister. A man can claim the same atonement as [would be his due] in his own case: a single atonement if a man lies with her. And [he has] the same [right] in the case of any women from whom he is to inherit or of any woman whom he has in his household, if she has no heirs in the country here. (Gulathing 143)

When a woman was raped, it was a slight on the man who was entitled to inherit from her, or who was to give her a dowry. The atonement was not paid to the woman.

Monetary atonement (or payment in kind) was the primary method of punishment for crimes which did not require exile. In the case of rape, and some types of theft payment would settle the dispute. The distinction in the punishments for stealing was based on class,


"If a well-born women steals, she shall be driven out of the land...If a man's freedwoman steels, or a native bondwoman, one of her ears shall be but off. If she steals a second time, the other ear shall be cut off; and if she steals a third time, her nose shall be cut off; After that she shall be called "stumpy and stubby" and let her go on thieving if she likes." (Gulathing 167-168)

This distinction may be because a well born woman would not need to steal to survive. Miller argues that theft was judged harshly because of secrecy. For example, it was not as bad to kill someone if you announced it ahead of time; secrecy was the worst part of the crime (Miller 89). We see other examples of theft in the Njal's Saga; again we turn to Hallgerd for an example of a woman committing a crime. She is accused of stealing a cheese, then giving it away as a gift. When Gunnar finds out about it, it is his responsibility to make amends (Njal's Saga pp 83-84). In this case, Hallgerd's inability to participate relieved her of some guilt in legal matters (though surely Gunnar was not Concluded on page thirteen

he got home). Even though the crime was Hallgerd's, Gunnar is required to atone for it.

Women's separation from the legal system was a detriment on one hand, but a blessing on the other. Women were not always able to settle disputes to their liking due to the requirement of male representation; however they were also exempt from guilt in many circumstances. The legal place of women in Scandinavian countries was complex and changeable depending on her class, the support of her male relatives, and the country in which she lived, but it can be concluded that the system was not especially modern, nor were the women afforded a great deal of rights in the legal sphere.
