Because I shall be leaving on Friday, March 28 to travel to Tir-i-don; I shall be 'at home' the previous Friday, March 21.


Please join me as you can, and bring newcomers to meet others in the Barony in this informal setting. Should you have any special projects, let me know, and we can work together as need be.

Barony of Storvik Financial Policy -

#### Preamble

The Barony of Storvik is a Barony of the Kingdom of Atlantia of the Society for Creative Anachronisms that includes the District of Columbia, Prince George County, and a portion of Montgomery County residing within the Washington Beltway. The SCA has a long history in the Metropolitan Washington, DC area. Each SCA group has a distinct culture and flavor. There are so many groups within the area, that it is common for SCA members to tend to associate with a group based upon a commonality of interests, rather than what group they may reside in. In Storvik, we consider members of the Barony to be those members who actively participate in the operation of the Barony. We welcome all to join us, and to make the Barony of Storvik your home. Come to our business meeting, advocate your interests and lead others who share your interests.

# New Business (Continued)-

#### 1. This Document

- 1.1 The Financial Policy for the Barony of Storvik is established in order to provide adequate control of the financial transactions of the Barony. These policies will ensure our compliance with regulations pertaining to our tax-exempt status and maintain the continuity of our administrative functions in support of our event-related activities.
- 1.2 This Document shall be accepted by a 2/3 majority vote of the populace of the group and replace all previous financial policies and may be amended or replaced by a majority vote of the group
- 1.3 This document is superceded by: Kingdom Exchequer Policy, Kingdom Financial Policy, Kingdom Law, Society Exchequer Policy, Corpora, State and Federal Law.

### 2. The Chancellor of the Exchequer

- 2.1 The Exchequer shall maintain a checking account with appropriate signature cards for the group, file all quarterly and event reports as required by Kingdom and Society law and policy, enforce and maintain the group's financial policy, serve as chairperson of the group's Financial Committee and hold primary responsibility for coordinating with other members of the Financial Committee, and communicating the committee's actions with the populace.
- 2.2 The Exchequer shall, upon request, provide access to the group's financial reports and books to any member of the group and shall publish to the group the annual doomsday report.
- 2.3 The Exchequer shall pursue any NSF checks received by the group according to the policy outlined in the Society Exchequer's Handbook. The Exchequer shall inform the Kingdom Exchequer of the specific details of the presentment and dishonor of the check.

#### 3. Financial Committee

- 3.1 The group Financial Committee shall consist of the Exchequer, the Seneschal, and the Baronial Checking Account Signatories, and any other members elected by the Barony. Each member of the Financial Committee must be a paid member of the Society for Creative Anachronism, Inc., be at least 18 years of age.
- 3.2 Members of the Financial Committee shall have one vote and recuse themselves from voting on any financial decisions in which there is a conflict of interest or appearance of impropriety.

# New Business (Continued)-

- 3.3 The Financial Committee shall review all proposed expenditures. Between Barony meetings, a minimum of two members of the Financial Committee may authorize any expenditure totaling up to \$250 or 10% of the group's unallocated funds, which ever is less.
- 3.4 The Financial Committee shall refer to vote by the populace any requested expenditure in excess of its permitted maximum; they may refer to vote by the populace any requested expenditure below their permitted maximum.
- 3.5 The Committee shall report all of its activity to the populace at the next regularly scheduled meeting.

#### 4. Baronial Votes

- 4.1 All voting to approve expenditures shall be at a regular business meeting and be by a 2/3 majority of the attendees.
- 4.2 A vote may be postponed until the next Barony Meeting at the request of any member of the populace. Any vote on an issue may be only postponed once.

#### 5. Events

- 5.1 The autocrat shall present an itemized budget for an event to the Financial Committee for review.
- 5.1.1 The Financial Committee must authorize any itemized expenditure in excess of the approved amount.
- 5.2 Event reservations and check in (troll):
- 5.2.1 All checks shall be photocopied and deposited in a timely manner, per Kingdom Policy.
- 5.2.2 No funds shall be removed from the check in cash box except as change for funds received.
- 5.3 Event Refunds shall be provided as follows:
- 5.3.1 No refunds shall be provided if the event does not make a profit.
- 5.3.2 The Exchequer must receive refund requests in writing no later then seven days after the event.
- 5.3.3 All refunds shall be paid by check from the group's checking account.
- 5.3.4 No refund shall be issued until the event books have been closed and all reservation checks have cleared.

# New Business (Continued)-

- 5.4 Receipts for expenditures for an event must be turned in to the autocrat within 7 days of the end of the event.
- 5.4.1 Any advanced funds not supported by a receipt must be returned within 7 days of the end of the event.
- 5.5 The event financial report shall be presented to the populace at the first regular business meeting of the group after the event books have been closed.

# May 10--Storvik: Knightly Day on the Mall

Storvik has been tentatively granted permission to use the National Mall (south of Constitution Ave, between 14th and 15th streets) to host an SCA Demo on May 10. This permit is based upon two contingencies--that the land is not being developed (which may still happen) & the Park Service approves our application. Info expected in March. For the demo we neeedHeavy Fighters, Fencers, Performers, and Artisans.

Our demo area has been divided into three: 1st, a tournament area shared by the heavy fighters and fencers. Interested fighters make themselves known to me. Lord Perrin will be the marshal for the day. Additionally we need a fencing marshal, and fencers. 2nd, a performance area for dancing, acting, singing, etc. I would like to have this organized in the following manner: the "leader" of a group willing to demo contact me with a preferred time allotment and I will schedule them to use the area. 3rd, an arts and science display. These can be shown on a table, or thru live demo.

Some of the things to keep in mind about the site:

1. Bone dry 2. No food or drink provided to spectators; only some for ourselves. 3. No archery. 4. No live steel; however "Olympic style fencing" equipment is allowed (foils-okay; leave the Schlagers at home). 5. We need to provide our own chairs and tables
