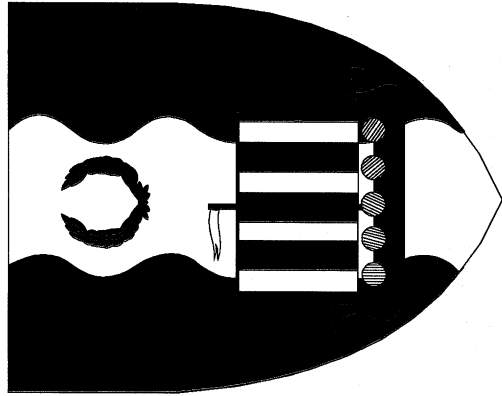

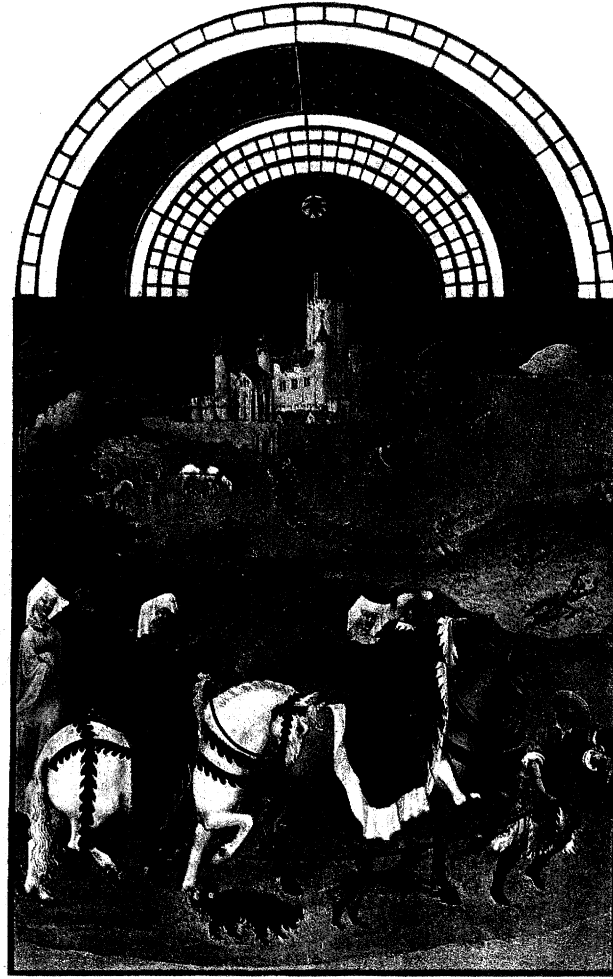

- Baron & Baroness - Brenna reports much merriment at the Moghul Sweep

- Minister of Arts & Sciences - Not present.
- Chatelaine - The latest Tintanbulum is underway and should be ready by March; it will be included in that month's Drekkar. Garb is still at the Exchequer's house.
- Chancellor of Children's Activities - First meeting was held at Corun's and seemed successful.
- Chronicler - The next Drekkar should include a Barony map (See page ) to make it easier to find events. The March issue will be the final one for the covers pre-made by the previous Chronicler. The Subscription Reports for the Exchequer and the Kingdom Chronicler are ready. For one brief shining moment (?) the Chronicler was suggested as a possible future Baronial candidate; this idea was immediately squelched when the Chronicler gave the assembled worthies the choice of his being either Baron or Chronicler—apparently the latter is a more desperate need.
- Exchequer - Barony Financial Report is complete, awaiting appropriate signatures. The Doomsday Report is 90% complete. It is uncertain who is currently safeguarding all the funds from the Performers' Revel, but Fevronia has her check and her funds are to be submitted to the Exchequer. "Novice Tourney" is as of this date not being held, but work is proceeding on an attempt to reverse this. It was cancelled because of a conflict with the Kingdom Arts & Sciences Festival.

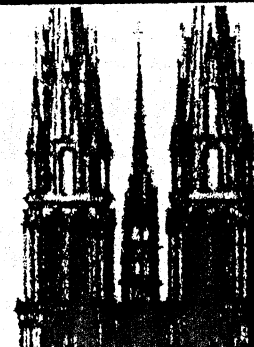
## A DAY OF DANCE

No fighting, no feast, no court, just dancing. And, it is FREE. It will be held at the University of Maryland Armory in College Park, Md.

There will be several tracks of instruction at all levels of experience from 1 p.m. until 5 p.m. (site opens at noon). Subjects include Playford dances, from basic to advanced, Italian basse and balli dance, Arbeau bransles, and Middle Eastern. After a dinner break from 5 p.m. until 7 p.m., there will be an opportunity to show off all your new steps at a ball (without teaching) from 7 p.m. until 10 p.m. Further details of the classes and instructors will be posted on line. UPDATE! Due to a renegotiated site cost, there has been a price decrease from last month's fees. (HUZZAH, etc.) The price for all this merriment? Until March 1st, \$5.50 offboard and \$11 onboard. After that, \$6.50 and \$13. For those coming from the St. Patrick's Day Bloodbath, the fees are only \$1 offboard, \$6.50 onboard. Smalls under 14 years of age are half price, under 7 are guests of the Shire. Remember, moose are not native to our lands and the Vikings who have to share a small, open boat all the way from Vinland with an irate—and seasick—moose are charging us dearly. Also, the site is just off the King's Highway and MUCH closer to those gentles coming from the East and South than in previous years.

### DIRECTIONS:

If you are coming from the North, South or West of Frederick: Take your best route to I-70 East in Frederick. Take exit #56 (Route 144) eastbound (make a left at the light). The armory will be your first right (it's across from the Park-and-Ride Lot on the opposite side of the road). Look for the "Armory" sign. If you cross the Monocacy river, turn around. You went too far.

If you are coming from points East of Frederick: Take your best route to I-70 West to Frederick. Take exit #56 (Route 144) westbound (make a right at the bottom of the ramp). Follow 144 for apx. a mile. The Site will be on your left, across from the Park-n-Ride lot. Look for the "Armory" sign (the sign will be on your right but points to the left) soon after crossing the Monocacy river.
