Until we next meet, I remain yours, in service to Our Dream,



Ten defenders in the guise of heroes of Greece & Troy will maintain the field & they shall invite 30 to declare their allegiance to the principles of chivalry as represented by three goddesses, & engage in combat a plaisance or a outrance in the customary combat of the SCA at the barrier or in the open field, as shall please them in choice of arms on that day. Three goddesses shall be the lady judges of these noble deeds of arms and at the end of the day, all three ladies will choose one champion above all others who they deem to best display the virtues of chivalry. The noble champion shall then be given the choice of Pairs, to name which goddess is the fairest. The purpose of this event is to recreate a pageant-style tournament from Europe in the year 1425. Therefore all attendees are strongly encouraged to attire themselves in armor and clothing of the period (+/- 25 years), or as such persons might endeavor to simulate the costume of ancient Greece or Troy.
