Minutes of Monthly Business Meeting, Jan 17, 2010

Officer's Reports

Chatelaine – (Tirzah) Tirzah is stepping down soon and is looking for someone to take over. Her warrant is coming up. No one has come to the newcomers' meetings recently. There is a new Kingdom chatelaine. Our former Kingdom chatelaine is now Society chatelaine.

Baron & Baroness – (Rorik & Janina) The Baron and Baroness went to Twelfth Night. Several Pearls and Dolphins were given but no peerages. Teleri earned her Pearl. The King does want awards to be surprises but wants recipients' families to be invited.

The Baron is going to Estrella in February. Janina is autocratting Performer's Revel. They may be going to many upcoming events. Since the current heavy combat champion is moving out of the area, a previous champion will be stepping back into the position.

Herald – (Patricia) Regarding the Shield of Storvik name registration (conflict), Patricia wrote to the heralds of the Midrealm and Principality of the Summits. She received permission from the Prince and Princess of Summits. She has not heard a final answer from Midrealm, but it looks promising. Patricia attended Unevent and was promoted to Pursuivant within the College of Heralds.

MOL – (Stefan) Went to Unevent; should be able to renew warrant.

<u>Knight Marshal</u> – (Constanza) Practice is going well, with no injuries. We were reminded to put things back where they

from in the hall - the important thing is to move things out of the hallway.

Exchequer – (Teleri) Patches is almost ready to be official deputy of the Exchequer. Teleri has the signature card ready to be taken to the bank to add Patches and Beatrix. Teleri is sending event reports from last year to autocrats to help them make budgets for the events. Gave a receipt to Kunigunde for donation of glass beads. If anyone else needs receipts for donations, email or call Teleri. The bank account balance has not changed since last month except for one check sent to the Baron.

<u>Chronicler</u> – (Kunigunde) Did not go to Unevent. Sent in annual report. Discussion of printing newsletter.

<u>Seneschal</u> – (Orla) Submitted 4th Quarter report. Went to Unevent, talked to local barons about dates for events for 2010. All of our events for the year are Spiked. People should be thinking about whether they want

to run for Coronets (Baron/Baroness). We have until Crown until we find out who will invest our Baron & Baroness. One issue that came up at Curia was a discussion of changing the length of the reign, and they are taking comments on that. Currently Kings and Queens of Atlantia reign for five months or seven months, alternately.

<u>Quartermaster</u> - (Kunigunde) Needs to find a replacement. Kunigunde wants to put the armor in storage as she doesn't have room for it.

Fight and dance practice are cancelled on Feb. 8 as the hall is being used for something else.

Future events:

<u>Performer's Revel</u> - Reservationist has received two reservations so far. Janina has a budget prepared. If approximately 35 people attend, they expect \$420 (at \$12 each). Food usually costs about \$360. Usually there is not much profit. The entry fee is for food; there is no site fee. The Baron and Baroness will be selecting the baronial bard at this event. Patches motions to accept the budget. This is seconded and unanimously approved.

St. Aiden's Melee – (Kullock) Kullock has last year's report which he discussed with Abel. They may lower the fee to \$10 + \$2 camping. No MOL or cook have volunteered yet. They plan to do a sideboard lunch. Abel has said it will be the same as last year; Storvik will handle reserving the site and finances and the profit will be split 50/50. Since St. Aiden's Guild has no bank account, they usually donate their share to the kingdom. The Croom site is being used. The break-even point is about 50 people. They are expecting about 100 attendees. Members of St. Aiden's will cover the difference if there is a loss. It will include combat archery and siege as well as melee. Orla motions that Storvik sponsor this event. This is seconded and unanimously approved. Kulloch and Abel must provide a budget to Storvik by March.

<u>Golden Rose Tourney</u> - We were going to discuss whether Storvik would sponsor the event, but the Autocrat found someone else to sponsor the event so this is no longer an issue.

<u>Novice Tourney</u>, June 19 – (Constanza is Autocrat) Janina will cover the first ten non-member surcharges. Tirzah is the reservationist.

<u>Post-Pennsic Dessert Revel</u>, Aug 21 – (Andrew Roriksson is Autocrat) Rorik, Janina and Amber are helping Andrew with autocratting.

<u>Storvik Baronial Birthday and Investiture</u>, Sept 18 – (Beatrix is Autocrat) Janina says we are looking for an indoor site with kitchen. We are willing to give up the deposit for Croom if necessary.

Orla and others are unable to come to the February barony meeting (scheduled for Feb. 21). Teleri moves to cancel the February meeting since we will have little business to discuss anyway. This is seconded and unanimously approved.

Joscelin and Isabel d'Angelo are now co-web ministers for Storvik. We are waiting for their warrants to go through.

Old Business

Silverware – still pending (waiting for it to go on sale)

<u>Order of order badges</u> – Rorik is still waiting for an answer from the vendor and will write again to place an order.

New Business


Poeta Atlantiae - There were only two entries to the Poeta Atlantiae poetry contest. Teleri is moving the contest to Ymir.
