Schedule for Letters of Intent

All Letters of Intent from candidates for the positions of Baron and Baroness of Storvik have been provided to Their Royal Majesties, the Kingdom Seneschal, and the Storvik populace by 31st of May.

A draft of the polling letter needs to be provided to Their Majesties and the Kingdom Seneschal by June 7th.

Labels need to be requested from the Kingdom Seneschal by June 7th.

Pollings need to be mailed to the populace by June 21st.

Pollings must be returned to Their Majesties by July 15th.

Candidates will be notified of Their Majesties' decision on or before August 20th.

The new Baron and Baroness will be invested at Storvik Baronial Birthday and Investiture on Sept. 18.

Letters of Intent, in the order received:

Greetings unto Their Most Royal Majesties Jason and Gerhild and to the mighty populace of Storvik,

I, Lady Tirzah MacCrudden, wish to serve the Barony of Storvik as the next Baroness.

With this in mind let me tell you about myself, what I have accomplished in the SCA and why I should be your next Baroness.

I have been a member of the SCA for 15 years. Most of that time has been spent in our fair Barony of Storvik. I began my SCA experience in Caid and have spent some time in Trimaris, but have always come back to my true love, Storvik.

May 2010 Storvik meeting minutes 05/16/10

Attendees: Kunigunde von Darmstadt, Sorchia Crowe, William le Younger, Johanna von Sudeborn, Rorik Fredericsson, Stefan of Cambion, Teleri the Well-Prepared, Orla Carey, Patches, Tirzah MacCruden

Johanna's Lost & Found list from St. Aiden's Melee event: 1 marshal staff, 1 gray hood/mantle, 1 target archery arrow with blue & white fletching, 1 water bottle (claimed by Kunigunde)

Meeting called to order at 7:25

Officers' Reports:

Chatelaine - (Tirzah) There were six new people in garb at St. Aiden's Melee College. Tirzah needs a replacement chatelaine. Rorik: Corpora says Baron & Baroness can be exchequer or seneschal. Orla: Atlantian law says they cannot.

Seneschal - (Orla) The Acorn will no longer be printing the seneschal's address. Nothing else to report.

Chronicler - (Kunigunde) needs letters of intent which are to be published. These go to baronial chronicler and seneschal, kingdom seneschal, the Royals and the Storvik list.

Baron & Baroness - (Rorik) Rorik attended Guppy Gala. There were 14 attendees and 2 fighters, and it rained, which made for small crowds. However, the 40'x40' tent provided by the zoo was well used. St. Aiden's was a beautiful day and a good event. Baska made a great dayboard with plenty of liquids available. Stefan: there were close to 50 fighters. Tirzah: There were 106 attendees.

MOL - (Stefan) At St. Aiden's Melee, Kunigunde arrived first and handled MOL sign-in for a while. Kunigunde says she just needs to do a youth combat event to apply for an MOL warrant.

Exchequer - (Teleri) Quarterly reports were sent in on time. Teleri will have Patches help with the next report for practice as deputy. Teleri's warrant expires soon but she should be able to re-up online. Storvik's net worth is \$6,078.84; ledger balance is \$2,995.78. The difference is in assets. Johanna says she attended exchequer class with Helena.

Past Events:

St. Aiden's Melee College: Tirzah: Seneschal gets the waivers; exchequer gets the other paperwork. Discussion between Tirzah and Teleri over pre-reges, comps and troll papers for St. Aiden's. Gross income at Troll was \$1,073. The budget of \$720 was spent. Half of the income goes to Storvik and St. Aiden's Guild will donate the other half to the kingdom.

Future Events:

Novice Tourney: (Constanza is autocrat) Novice is our next event. Finn is Marshal in Charge. Bruce the Robert from Bright Hills is the head cook. The event flyer will be in the June Acorn. Teleri asks how she will get a check to Constanza for the Troll's cash box. Johanna volunteers to take the check to the head troll at the event or to run troll if necessary. We later reached Constanza via phone to learn that the Head Troll is Johanna; Sean de la Mare is Marshal in Charge; and the head cook will be reimbursed after the event.

Post-Pennsic Revel: (Andrew Roriksson is autocrat) They have a head cook and head troll for the event.

Storvik Baronial Birthday & Investiture: (Beatrix is autocrat) Head cook is Graça Esperança de Sevilla. Johanna suggests renting a large tent from Bright Hills in case of rain. They are still looking for a site with a real kitchen, otherwise it will be held at Croom.

Old Business:

Baronial Investiture process: Timeline has been posted to the Storvik list. All letters of intent must be sent to the Royals and populace by May 30 and published in the Drekkrar shortly thereafter. Orla has to submit the draft of the polling letters to the Royals by June 7. The polling must be mailed to the populace by June 15. The deadline for returning the polling to Their Majesties is July 15. Their Majesties' deadline to inform Storvik officers of their decision is August 20 (4 weeks before Birthday). The King & Queen plan to be at Birthday. Discussion of Royals/Highnesses at multiple upcoming Investitures.

There will probably be an envelope-stuffing night at fight practice on June 14. Orla requests \$200 for mailing supplies for the polling, noting that this cost has been increasing. This is unanimously approved.

Medallions: Orla has to contact the medallion maker because he has not contacted her yet.

Storage shed: The shed will be moving to Thomas' of Cheltenham near Croom. We need to determine dates to move. Moving will involve taking apart the shed, moving and inventorying items, laying the pavers and putting the shed back together. We also need to get in touch with Thomas regarding a date.

New Business:

Quarterly report: Teleri paid \$4.95 to copy and mail the report. Tirzah moves to reimburse Teleri. This is unanimously approved.

Pennsic dance - Beginner's Ball: Patches ran this last year with a donation from Storvik. She does not have a budget with her but can prepare it for the next meeting.

June business meeting: This is the day after Novice Tourney and many people will still be on site. We could have the meeting at 11am on site (to be off site by 12) or at 7pm at the church as usual. Consensus is to have it at St. Andrew's church at 7.

Dance group: Patches says some fighters have been staying to dance after fight practice. The dancers welcome new dancers and musicians!

Leftover food after feasts: Johanna says that in Storvik culture, leftover food is offered to the populace. She suggests that we establish a policy of offering leftover food to attendees. This will prevent arguments from "foreign" cooks (from outside of Storvik). Discussion of current culture - the food is already given out. Is there a need for the policy? Patches: We should just discuss it with the cook. Johanna: In some baronies the leftover food is divided by the cook and kitchen helpers and not offered to the populace. Kunigunde: Setting a known policy may encourage people to not pay for the feast but wait for leftovers. William: If the autocrat wants to donate food to a homeless shelter will this policy prevent it? Tirzah: Shelters will not take food unless it's sealed or in an unopened bag/box/can.

Orla moves that an addition to financial policy be made which says that any leftover food from feast or sideboard shall be offered to the populace at the event. Donations may be requested at the discretion of the autocrat and head cook. Sorchia seconds the motion. It is unanimously approved.
