Minutes of Monthly Business Meeting, Oct 17, 2010

Attendees: Kunigunde von Darmstadt, Tirzah MacCrudden, Orla Carey, Teleri the Well-Prepared, Patricia of Trakai, Patches, Griffin Warfogger, Ysende Herberiour, Shari Malin, William the Younger, Sorcha Crowe, Elizabeth Harlyn, Stefan of Cambion, Lynette Semene, Charles Kane

Meeting called to order at 7:10 pm.

<u>Chatelaine</u> - (Tirzah) Need to find a new chatelaine as Tirzah's warrant is expiring. A father and son say they are coming to fight practice, so someone should look for them and greet them.

<u>Baron & Baroness</u> - (William & Sorcha) They went to Roxbury Mill's event. The Storvik team came in second (Nuala & Geoffrey). William won the A&S competition with his Savonarola chair. The event was very windy. Roxbury Mill allowed William & Sorcha to open a court to give a Lozulet to Nuala. The next event Sorcha is attending is TNT and both will be at Crown Tourney.

<u>Chronicler</u> - (Kunigunde) September Drekkar is out. Her warrant is expiring in November but will renew it. A few folk have offered to send in articles for the newsletter. We will try to increase readership.

<u>Exchequer</u> - (Teleri) Teleri has taken a retraining class and learned she should be keeping more backup on expenses and event budgets. She suggests setting a \$100 annual budget for office supplies at the beginning of the year. There was a \$300 donation from fight practice. Teleri needs to have her warrant signed. Bank balance is \$9,568.15. SCA Inc., MD is breaking off from Corporate for audit purposes. We may have to change the bank account name. This should take place by the end of the year. Since Storvik is in both MD and DC, we're waiting to hear which we should use. Orla says we will have a new tax ID and will need new bank signature cards. Stefan asks if the new group will need to apply for a 501(c)3. Orla says probably not since it's a branch of a larger group. We will have to remember to write checks to the new name. Teleri says Beatrix's membership has expired and she has been taken off the bank signatures list. She has not responded to Teleri's email. Other Atlantian groups report there is a \$2 checking fee monthly. We should consider whether we want to pay it or change banks.

MOL - (Stefan) No news. Kunigunde would like to be added to the MOL Deputy list.

<u>Herald</u> - (Patricia) The Atlantian College of Heralds liked the award name Shield of Storvik and passed it along to the College of Arms. This award is to recognize achievement in continuing service, fighting, etc. The 3rd Quarter report has been submitted. Ruadrigh did not submit a court report for Storvik Birthday yet but Patty will address that. She will work on finding a deputy herald and training someone. Kingdom Triton Principal Herald Master Bran is coming up and wants to meet with local heralds. Patricia will be coming up to her term limit soon. <u>Seneschal</u> - (Orla) - Unevent is in Winston-Salem the first Saturday of December. If officers can't go, they should find a proxy to sit in their meeting to take notes. Crown Tourney is in Leesburg the first weekend of November. 27 people applied to compete.

Old Business

<u>Storvik Medallions</u> - Orla is passing info on to Sorcha to contact the former medallion maker. Teleri has someone else in mind.

Financial policy - We will discuss this at the November meeting.

Rubber stamps - (Teleri) Not purchased yet.

Coronets - (Sorcha) She is getting an estimate of the price (up to \$150).

<u>Meeting room</u> - The lease on the room we use for the meeting expires in November. The price is going up by \$1.50 a month, putting the lease at \$200 a year. Attendees discuss and agree that the increase is not unreasonable. William moves that we sign a new lease at the new rate. This is seconded and unanimously approved.

<u>Fighter practice</u> - The cost of renting the hall for fight practice is going up. Orla thinks we should sign a one-year lease but start looking for a new site for fight practice.

<u>A&S</u> - Teleri suggests renting a room at the same time as fight practice for A&S. Ysende suggests we not hold it all together as dancers and fighters would not be able to attend the A&S meeting. Ragnarr says there would be more people wanting to come to A&S than fighters upset they couldn't go. Orla says we could probably get the meeting room for \$200 but we need an A&S minister to keep it running and encourage attendance (Storvik's MoAS stepped down). We should shelve this until we find a MoAS. Sorcha suggests we add Troll class, MOL class etc. Teleri moves that we renew the lease for a year on the hall for fight practice. This is seconded and unanimously approved.

New Business

<u>Funds</u> - (Teleri) Since fight practice is such a large expense, we should set up a fund to allow donations to be given directly for the fight practice. This will allow us to track money coming in for this purpose. Storvik's donations currently all go into the General Fund. If we don't have enough in the fight practice fund it will come from the General fund. William says if there is enough in the fund to cover a year of fight practice, people will think they don't need to donate.

<u>Tabards</u> - (Sorcha) It is the Baroness's desire to make new fighting tabards. This may make it easier to recruit fighters. The budget is \$248 for fabric plus more for the embroidered patch. Griffin says he and Ysende have an embroidery contact. Lynette created a file for the drekkar ship and can do the dragon head. Angel and Brenna may already have the file. Further discussion tabled until next meeting.

Iron Key / Quartermaster - Griffin is the new Iron Key and will get the loaner armor from Kunigunde.

<u>Armor Repair Night</u> - Griffin will host armor repair night at his house. He will figure out when he wants to make an announcement for an armor drive. (2nd and 4th Wednesdays of the month, with A&S at 2412 Oak Glen Way, District Heights, MD 20747)
