Minutes of Monthly Business Meeting, August 21, 2011

Meeting called to order 7:15

Officers' Reports

Webminister - Aaradyn - Nothing new since before Pennsic. The new website will be in beta test soon. She will make updates which have recently been requested. She confirmed that she is receiving email addressed to webminister <at> storvik.atlantia.org.

Exchequer - Teleri - 2nd quarter reports have been submitted online but the hard copy was sent in late. She did not receive the July statement from the bank. She will clear this up with the bank and make sure

they have the correct mailing address. She should be available to do the third quarter report.

Herald - Patricia - She did not attend Pennsic. She just finished the last court report for Novice Tourney. She hopes to be at Atlantia's 30 Year Celebration, if she can get a ride. She has not been holding heraldry night because people were away at Pennsic. She will think about holding it tomorrow or next week.

Chronicler - Kunigunde - Nothing new. The last Drekkar was out on time. (correction: was not out on time.)

Baron & Baroness - Sorcha - Carlisle was squired at Pennsic; Tirzah was in the camp of Strawberry Fields; our rapier fighters made it to the last round of the 5-man melee; Baron or Baroness are going to four events coming up and should have Storvik camps at three of them. She is working on a coronation gift. B&B expect to be at Crown Tourney and Sorcha will be at WoW and 30 Year. She is not sure about William. Sorcha is in contact with Thorbrand about adjustments for the coronet. William has plans for a new shower to use at Croom.

Seneschal - Orla has two warrants prepared - Johanna will be Arts & Sciences officer and Tirzah will help her. Devan will be Seneschal in September; this is Orla's last meeting. This will go into the court report at Birthday. Orla will be taking a six-month break from volunteering but will be available to answer questions.

Regarding the date for Novice Tourney in 2012, Stierbach has Spiked the third weekend in June. Dun Carraig has plans for the first weekend and the second is University. Orla Spiked the fourth weekend (22-24) (to get it in before that weekend was also taken). Sorcha thanked Orla for catching this (with thanks to a call from Lynette.)

Events

Storvik Baronial Birthday - Kunigunde - Johanna needs a check for the Troll box and one for the head cook (Mistress Caitlin.) Teleri or Johanna might be able to run A&S. Kunigunde will order site tokens.

Sorcha suggests working with Lochmere for a

joint Fall event. Orla suggests establishing a date. Sorcha would like us to drop the Fall event (Birthday) if necessary to hold a Kingdom-level event. Devan motions that we Spike Sept 15 for our event next year. This was seconded and unanimously approved. Kunigunde volunteers to Autocrat and Spike the event unless someone else wants to volunteer.

Storvik Novice & Unbelt - Orla has Spiked Storvik Novice but we still need to find an Autocrat.

Old business

Medallions - Tirzah suggests Billy & Charlie pewterers. Orla will ask Bess to contact our prior medallion maker again.

Seneschal - Devan needs to be added to the bank signatory list. She suggested that we look into a credit union, if they allow business accounts. We are considering other banks. We used to be with Bank of America before the current officers came into office. The SCA has certain rules like "no online access" and "no ATM card" because withdrawals/checks need two signatures.

Devan will be Seneschal officially on September 18th.

New business

Croom Improvement - Devan said William has plans for a shower to be built at Croom. The budget is about \$350 for a heater and pallet floor and he will build the rest. \$240.75 has been raised so far for the Croom Improvement Fund. We will have to table this until he can provide a budget and discuss the options. Orla thinks we should buy the grill first. We need either another fundraiser or a vote to dip into the baronial funds.

Pewter-casting - Johanna said that Arianna from Tir Y Don is willing to come give us a pewter-casting class. These could later be enamelled. Tirzah suggests using zinc; it is harder but melts at a lower temperature and is cheaper. Our current baronial medallions are sand-cast pewter. Johanna suggested an embroidered patch for medallions which could be sewn onto garb.
