Minutes of Monthly Business Meeting, August 19, 2012

Officers' Reports

Seneschal – (Devin) Devin sent in the quarterly report but had problems with the webpage and will resubmit. She was told that someone had sent her email through the seneschal link on the webpage but she did not receive it. Aaradyn said she updated the webpage.

Exchequer – (Teleri) Teleri spent \$41 and change for deposit slips. On the Seneschal's authority, \$50 was spent to repair the Baron's coronet. She sent in the 2nd Quarter report. A number of people have money to deposit.

Webmaster – (Aaradyn) The Kingdom Webminister is changing recording to quarterly and is setting up a web form for submission of reports. The system for reporting issues with

the Kingdom website and bulletin board for actions at all levels is up and running. The Kingdom Webminister is pushing for a uniform look for websites. There should be some changes soon to the Kingdom website and Aaradyn will follow suit with the look for Storvik's. Aaradyn is looking for a deputy. Some software knowledge and HTML is required. A graphics background would be good.

Chatelaine – (Tirzah) The Chatelaine report was due during Pennsic and was submitted a little late. A few new people were at fight practice and there are a few folks who transferred from Trimaris. Our Princess is Kingdom Chatelaine, so Livia stepped up so that Kalisa can carry out her other duties.

MOL – (Kunigunde) Nothing to report

Chronicler – (Kunigunde) July Drekkar was out on time.

Baron & Baroness – (William & Sorcha) Two Lozulets were awarded at Pennsic, to Aaradyn and Devin. Sorcha will attend Trial by Fire. Both are attending Battle on the Bay. Zander and Wulfgar (Storvik youths) did well at Pennsic. Lady Tibbie carried Sorcha's favor in the rapier list. Rachel the Younger was awarded an AOA.

Aaradyn said the dance community was very proud of Patches for organizing the Beginners' Ball at Pennsic. It was highly attended despite the rain.

For War of the Wings, Ulfsbane and Storvik will be camping together. The Taj ma Hammer was damaged at Pennsic and will be repaired after BoB.

Herald – (Patricia) Aaradyn heralded Storvik's court at Pennsic. She has three submissions to scan and mail. She took some book heraldry classes at Pennsic to learn about changes in submission rules. She will hold heraldry night in a week at fight practice.

A&S – (Johanna) Johanna made baronial tabards. The Quarterly report is in. Do we want new tabards or baldrics for officers? Johanna wants us all to wear ghwazee coats in Storvik blue.

Coronet – William is getting a quote on a new spacer for his coronet so it will fit.

Refunds for Novice Tourney – Teleri said refunds went out for pre-registrations and attendees of Storvik Novice. She will figure out how to note it on the Quarterly report.

New Business

Facebook group – William requested that we set up a Facebook group. Aaradyn said there is one but it is currently set to 'secret'. Someone else set it up and we don't control it. Aaradyn will contact Facebook to ask if it can be deleted so we can set it up the way we want it. There's no way to change the owner. Right now, only moderators can post. Cameron de Gray and Aaradyn are moderators. Information on the Storvik Facebook page has links to the Yahoo group and Storvik's webpage. Patty said that FB doesn't allow for a change in moderators.

Events

Battle on the Bay – (Kunigunde is Autocrat) Aaradyn has started the map. Discussion of time for baronial court. William and Sorcha decided to do "drive-by" awards with Aaradyn as herald/retainer. William is marshaling youth fighting. Devin said she will charge \$6 for lunch. Tirzah suggested \$5 – it is a lower price and will be easier to make change. Devin will use her and William's propane stoves. Tirzah offered some items. Propane tanks were discussed. Johanna suggested selling lunch tokens at Troll. Wyn should be reminded to bring the day shade. Johanna needs volunteers at Troll. Devin needs help fixing lunch.

Storvik Novice & Unbelt Tourney – Devin Spiked the event for the end of June at Croom. We need an Autocrat. Tirzah suggested looking into the church Dun Carraig uses, which is on Storvik lands. The kitchen and feast hall are indoors. We will see how Battle on the Bay goes as a joint event and then discuss whether we want to do joint events next year.

Joint events mean more attendees, more staff and more fun. Sorcha said if we become known for good joint events that will still be good for Storvik. Aaradyn said having baronial tabards and dayshade will keep Storvik visible.
