# **Officers' Reports**

<u>Seneschal</u> (Devan) – Novice Tourney date has been moved. We are waiting to hear from the Dun Carraig Seneschal to change Novice on the kingdom calendar and website.

<u>Chronicler</u> (Kunigunde) – Did not finish the Drekkar for last month yet.

<u>Webminister</u> (Aaradyn) – Dreamhouse was hacked but our site seems okay. There is nothing really confidential on the server that we should be worried about. She still needs to know what photo of themselves the Baron & Baroness want on the website.

<u>Chatelaine</u> (Tirzah) – Her warrant went through. We had a successful demo.

Exchequer (Teleri) – 4<sup>th</sup> Quarter and Domesday reports are complete but need a signature before being submitted. Shed needs to be inventoried and repaired. We need to approve an extra \$40 check for MNCPPC as they raised their rates for Croom. Devan paid this out of pocket and we should reimburse her. Teleri will send the financial report to Kunigunde for publication in the Drekkar.

Baron & Baroness (William & Sorcha) – went to Aethelmearc 12<sup>th</sup> Night. Sorcha won awards and Atlantia did well. They are going to KASF, Ymir, Ponte Alto Baronial Birthday, Performers' Revel, Feast of St. Pyr or Defending the Gate, Spring Coronation, and William is going to Gulf War.

MOL (Stefan) – Nothing new.

<u>Herald</u> (Patricia) – Order of Ullr's Bow passed Kingdom level and moved to the College of Arms. William's daughter's name has passed. It is better to wait until the name passes SCA level before submitting a badge to make sure they will be connected in the Order of Precedence. There was a backlog on the Order of Precedence but out last court has been entered.

#### **New Business**

<u>Rug at fight practice</u>- Baron Sean and Carlysle want to cut the rug at fighter practice in half – it is only used for kneeling on and people are tripping on it.

<u>Business cards</u> – we need to discuss new business cards.

# **Old Business**

<u>Medallions</u> – William has the mold and a test cast. It used \$4 worth of pewter and he says it didn't come out well. He is going to talk to Baroness Lynette or Master Chris Cunning (a Laurel in casting). The mold is unusable and was disposed of. It will cost about \$50 to carve out each medallion. William made a motion to commission one of the above artists to make a Lozulet mold and ten medallions. This was seconded and passed.

# Events

<u>Novice Tourney</u> (Rayhanna) – Carlysle said the new date for Novice is the same as Assessments.

William thinks there is little crossover between the fighters at these two events. New fighters go to Novice and knights go to Assessments. Sean recommended getting the event announcement out soon. Carlysle suggested holding the novice tournament at another event and changing the theme for our event. There was some discussion of useable sites. The plan is to hold a Novice tourney and an unbelt tourney and that's it (no melee). Carlysle is worried about ill will between us and the Royals. William said it will fall on the Baron & Baroness, not the populace. Devan said that Assessments is not a noconflict event. William said that we have few other options at this point. Our date was not available because MNCPPC is using Croom on our chosen weekend.

<u>National Geographic demo</u> – for Sunday, February 12. Devan will follow up with National Geographic. She will also follow up with Yseulte and the Pages Academy. Tirzah will make soup for the demo.

<u>TEFKABB</u> – Kunigunde set up a Google group. She will try to contact Lochmere. A few Storvik people have been added to the group. Kunigunde needs to contact Aryanna Hawkins who is the liaison. Name of the event is still under discussion.

<u>Performers' Revel</u> – Teleri asked who is in charge of promotion of this event. Sorcha will do it as Autocrat.

Carlysle asked questions regarding archery marshalling for Storvik events. Charles Sprouse would like to marshal an event. Nuala and Geoff usually marshal and build and set up targets with help from Needwood and Bright Hills.

<u>Crown Tournament</u> – Elizabeth Harlyn signed up on January 3 and reserved the date at Croom. She said they were taking calls for reservations while she was in line. Storvik officers thought we had to stand in line to make reservations. Crown Tournament is set for May 4, 5, 6 and will be a camping event. The Kingdom of Atlantia does not operate as SCA, MD, so essentially they will run the money through Storvik's bank account. The kingdom covers the paperwork and we will write them a check. William moved that we allow the funds for Spring Crown to go through our bank account. This was seconded and approved. Tirzah will be cooking and there will be runners to make sure the staff gets fed. It will be a 'rolling feast'. Nothing else but the tournament goes on at Crown. She is not sure about A&S or Tempore Atlantia. Jean-Maire is in charge of A&S and will ask Johanna. Bess wants to see a good baronial presence. William has nice tents and has been asked to lend one for royalty. We can tell other baronage they don't need to bring their day shades, as Storvik's B&B will invite them to share theirs. Duke Ragnarr wants to put out the challenge that each barony field a fighter. We'll ask Syr Richard to hang the banners he has made. \$12 will cover entry and food. Kunigunde will be MOL.

<u>KASF</u> – Aaradyn says we have six people registered from Storvik. She is waiting to hear back from some. Sorcha and Nuala are working on an Inter-baronial challenge for items that "represent the barony". It was supposed to go out via email and should go on the barony's list.

Teleri said her husband is offering \$10 to kill a boss on the video game Arkham City.

<u>Inventory</u> – William has the hardware to fix the shed. The date to work on it is Sunday, February 26 at 1pm.

Meeting adjourned at 8:04pm.
