# Minutes of Monthly Business Meeting, March 18, 2012

Attendees: Devin of Storvik, Tirzah MacCrudden, Sorcha Crowe, Aaradyn Ghyoot, Teleri the Well-Prepared (by phone)

Meeting commenced 7:00

#### Officers' Reports

Seneschal – (Devin) Devin received an email from Teleri outlining a change in the account signatory process. Wells Fargo has the paperwork adding her on as a signatory and did not require her to open a profile to do so. It seems having the account signatory papers signed by the correct individuals is all that is needed, according to the bank rep that spoke to Devin. A newcomer pointed out that the "seneschal" part of the email address is misspelled as "senschal," and resulted in bounce backs. The phone tree will be passed out at the meeting. Nothing else new to report.

<u>Chatelaine</u> – (Tirzah) 4-5 newcomer inquiries. One came to the Baron's At-Home. A few are coming to fighter/dance practice.

Exchequer – (Teleri) (absent but sent report):

Kingdom Exchequer is stepping down; our Maryland Regional is going to take the position. Not sure who will be the new Md Regional yet.

- \*First Quarter ends March 31. Time to write St Andrew's check for 2nd quarter.
- \*Q1 report due April 30
- \*\$600 check sent to Kingdom
- \*\$10 deposited to reconcile lost heraldic fees (Exchequer's error)
- \*Shed inventory did not happen
- \*Teleri thinks she would like to step down after the 2012 Domesday is filed in January 2013. She has asked Patches, her deputy, if she wants the job but hasn't heard back. If anyone else is interested, they should get in touch with Teleri and you will do this year's quarterlies with Teleri as your training/warranting process goes forward, so you're familiar with the process by the time you're Exchequer.

<u>Chronicler</u> – (Kunigunde von Darmstadt) (absent but sent report) February Drekkar is out; 2011 annual Chronicler's report has been sent in to the Kingdom Chronicler.

Herald – (Patricia of Trakai) (absent but sent report) Patricia held a "heraldry night" at fighter practice a few weeks ago. The next one will be on Monday, March 19. She prefers to do the consultations from 7-8 p.m., before the dancers get going. Baron Stefan asked her to do some preliminary conflict-checking on a proposed badge for Kingdom Historian. She hopes to forward some results to him by Monday.

Lady Aaradyn, our Webminister, would like to become a warranted herald for court and voice heraldry. Patricia will bring up the matter with the Triton Herald when she returns from her travels to the war in Meridies.

Crown Tourney should have lots of pomp and heraldry. Patricia thinks it would be great to have a heraldic consult table at Crown. It could also be a gathering place for the heralds. Here are the contacts:

During April Patricia will start posting reminders to the Storvik listserv for people to PLEASE send recommendations for baronial awards to Their Excellencies and to the Atlantian recommendation site for Kingdom-level awards. She will file the Herald's quarterly report when the first quarter actually ends. In non-heraldic baronial matters, Patricia was the second signature on the check that represents Storvik's contribution to the Kingdom for the settlement, and she put it in the mail to the Kingdom Exchequer.

<u>Webminister</u> – (Aaradyn) A great deal was broken on the website after Dreamhost was hacked. This caused revisionary problems after the transition to the new Dreamhost. Work on the website is on hold until Aaradyn's computer is fixed.

<u>Baron & Baroness</u> - (Sorcha) Baron William represented Storvik at Gulf Wars. Baroness Sorcha is going to Tir-y-Don investiture. Ponte Alto's 20<sup>th</sup> anniversary was attended by the Baron and Baroness. A gift of a case of beer was bestowed upon Ponte Alto's Baron and Baroness. In light of the Barony's tender age, Master Tirloch accepted custody of the beer. (Master Tirloch has passed away since.) Baron Igor and Baroness Fevronia will put up the Baronial day shade at Night Under the Town. It is unknown whether or not our Baronage will attend Defending the Gate. There was a request to move the decision on Storvik Court Painter to Crown Tournament. Aaradyn stated that we should not do this there since it is not a Storvik event. People might be confused and think we're referring to an Atlantian Court position. Teleri (by phone) suggested Novice Tourney.
