Officers' Reports

Exchequer – (Teleri) Closing out Crown Tourney (books) is almost done. We should order some deposit slips. We have about \$8,956 in the bank.

<u>Webminister</u> – (Aaradyn) She received some corrections from Kunigunde and will update the webpage. It is harder to update now. Any future webministers will have to know HTML; there is no WYSIWIG program. Aaradyn is using Dreamweaver and Filezilla. We don't know who the deputy webminister is who is listed so we are removing her name and sending her an email to let her know.

Chatelaine – (Tirzah) She turned in the 2012 report and had to resubmit because it got lost, but it was still in on time. There are a few newcomer kids; they seem happy. Other new people this year have kept coming back. She will be at Ruby Joust's Chatelaine meet & greet. Sorcha said, There are some military SCA people moving to this area; we should contact them.

Chronicler – (Kunigunde) Nothing to report.

Baron & Baroness – (Sorcha & William) Richard Wyn is the new baronial court painter. They had an awesome time at Spring Crown. They believe this is the first time a territorial baron fought in Crown on his own lands. They had a presence at Tir-Y-Don Investiture and will also be at Stierbach Investiture. Both will be at Ruby Joust; Sorcha at Highland River Melees. William requested space by the field for a day-shade at Ruby and will need help setting up the tent. William should talk to Gracie about youth marshalling.

<u>Herald</u> – (Patricia) She had lots of heraldry stuff going on at Crown Tourney and a number of senior heralds in attendance. Aaradyn is now warranted and she heralded the Baron and Baroness into court. No heraldry night tomorrow – the next one will be in June.

<u>MOL</u> – (Stefan) Stefan handed over the MOL banner and "hat" (job) to Kunigunde.

<u>A&S</u> – (Johanna) Johanna held A&S meetings. Jean-Maire is planning an Italian practicum in June.

Old Business

<u>Water heater</u> – William brought estimates for portable tankless water heaters designed for a single shower. They were \$129 to 189 for a single, including fittings, or \$259 for a double, two showers (at the same time). The Croom improvement fund stands at about \$240. Teleri motioned that we spend up to the amount in the fund. This was seconded and approved. Teleri donated hosing for the shower.

Medallions – Lynette is working on medallions.

<u>Grill</u> – Tirzah has priced grills. The estimate is \$300 for a 4-pipe grill. William moved that we spend the money from the general fund. This is seconded and approved.

New Business

<u>Deposit slips</u> – Teleri would like to buy some deposit slips. She made a motion to purchase deposit slips. This was seconded and approved. William made a motion to get a self-inking signature stamp with "For deposit only". This was seconded and approved.

<u>Storvik tabards/baldrics</u> – Johanna wants to buy linen for Storvik tabards and baldrics but cannot find the right shade of blue. William insisted we should not hand-dye the linen as it is a lot of work and the color tends to run in the wash. Tirzah said Darma Trading Company has the right dye and mordant plus instructions. Johanna made a motion that we spend up to \$300 for linen fabric, and dye if needed. This was seconded and approved.

Events

<u>Novice Tourney</u> – (Rayhana is Autocrat) ACCEPS is up and we can pre-register. She still needs a rapier marshal. Johanna recommended a marshal in Bright Hills. Rayhana requested checks for prizes and expenses from Teleri. The next meeting is two weeks before the event. Aaradyn has the website live and a site map is ready. A map and schedule will be handed out at the gate. The Princess is planning to come. Tirzah and Devin will get checks at the next meeting (change for Troll box, and money to purchase feast food).

<u>Battle on the Bay</u> – (Kunigunde is Autocrat) The budget was discussed. The site fee should be updated to \$520. We are planning on \$12 for site fee and \$12 for feast. Kunigunde will send out the budget to be voted on and then share with Lochmere and attend their meeting if possible. She will check on A&S. Propane comes out of the event budget. Together we have a lot of propane tanks. If the grill's tank was owned by the barony, we would have to store it. Teleri asked where the grill will be stored. Tirzah volunteered to house the grill. She will get it from Sam's club.
