#### Minutes of Monthly Business Meeting, June 9, 2013

Meeting commenced: 7:01pm

#### Officers' Reports

<u>Seneschal</u> - (Devin) – Letters of intent went out and were approved by Their Majesties. Devin will send a reminder to update membership so everyone gets a polling letter. We are waiting to hear from Regional and Kingdom officers to verify zip codes in the Barony and then get labels from Society level. Individuals warned Devin to double-check the labels to make sure they are in our barony as there have been some errors in the past.

<u>Chronicler</u> (Kunigunde) – June Drekkar was

out on time and she contacted Grazia Morgano for help getting to the webpage to upload newsletters since they are supposed to be posted on our webpage as well as our Yahoo group.

Knight Marshal (Carlyle) – Carlyle is now our official Knight Marshal. There was some discussion about the length of time it takes to become a youth MiT and to get the background check done. They submit a background check when one is ready to become a marshal. Carlyle reported that there have been no injuries at practice this month.

Exchequer (Tirzah) – There is about \$7,000 in our bank account. We received a reimbursement check from the kingdom despite telling them to keep it (February 2012 meeting). We are going to send it back. Kunigunde asked if we should cut them a new check from Storvik. Graçia said that that is the way to direct the donation to the travel fund.

Baron & Baroness (William and Sorcha) - William held an armor workshop June 9 and there were a lot of attendees. They learned what Their Majesties want to change, which was discussed at Curia. Grazia Morgano was awarded the Fountain and AOA. Orla said they are starting to film courts so that people can see them online. William is going to Novice Tourney and Pennsic; Sorcha will be at Novice. He has not decided when baronial court will be at Pennsic. They have Battle on the Bay "save the date" post-cards to hand out. Patricia pointed out that the dates are wrong on these post-cards. Sorcha is collecting items for feast basket prizes for newcomers at Novice. Aaradyn is offering something for the Trimaris gift basket. The Baronial-At-Home will be at William's for July.

#### **Old Business**

Knight Marshal – Carlyle is warranted as Storvik's Knight Marshal.

#### **New Business**

Date of meeting – Orla proposed that we change the date of the meeting. There was some discussion of days and events. It was mentioned that if we are going to change the day of the meeting, it should be open to discussion on the Yahoo group to receive input from more barony

members. William suggested we wait until the new Seneschal steps into office in September. Devin said that we are only required to have four meetings a year. Tirzah said that that would make it look like the barony wasn't doing anything. Kunigunde said that Chroniclers are required to put out a monthly newsletter, and with no meeting minutes it would be mostly empty. Badouin said that we could hold more activities such as potluck dinners, going to a restaurant together after the meeting, and board-game nights. Kunigunde said that she would like to see A&S nights announced far enough in advance that we can put them on the schedule.

Carlyle made a motion to move the July meeting to July 7. This was seconded and approved. Graçia pointed out that we rent the meeting room for four hours, so we could do a potluck, A&S or boardgames in the hotel conference room.

#### **Events**

Novice & Unbelt Tourney (Carlyle is Autocrat) He has only received one pre-reg but has had a lot of field requests. There was discussion of a Storvik populace tent in the Storvik lean-to since Sorcha and William will be in the Taj Ma-Hammer with the Royals. The event cost is \$15 adults, \$5 for camping and \$8 for youth. We are not using Acceps this time. Kunigunde is still looking for MOL help. [note: this has been resolved]. The picnic pavilion is not being used for much – maybe a Herald's table and a couple of classes. There are prizes for Novice champions. The MOL table will open at 9am and authorizations start at 10. Badouin said that Llyr was interested in being the entertainment coordinator. Kunigunde will be MOL. Lady Wynne ferch Rhodri from Bright Hills will be children's activities coordinator. Grazia Morgano will coordinate pavilions.

Meeting adjourned: 8:00pm

Congratulations were given to Baroness Sorcha on receiving the only perfect score awarded at the Inter-Baronial Brewing Smackdown at Highland River Melees.
