#### **Events:**

Fall Coronation (Kunigunde): \$1,905 profit each to Kingdom & Storvik; will have to have event report signed later after we are able to print and get together.

Spring Fair (Mirabella)– Stopped looking into it because she thought we did not get the site for the weekend we wanted, had trouble finding another site. Celric – since it's only 4 months away, maybe we should put it off to the next year. Let's continue looking into it. William – Highland Havoc was successful in an event like we're planning, with a lot of horses and archers. Celric – asks Mirabella to set up a committee with B&B, Mirabella, William, Kunigunde, to pull together the information in the next two weeks and discuss it at the December meeting.

Battle on the Bay (Kunigunde): assembling staff.

Storvik Novice (Sonya): Got the contract for June 27, concerned about the swim meet also using the site, asked how to ensure that won't happen. They said they will see our event on the calendar and not schedule something else..

## **Old Business:**

- Baronial financial policy: Marguerite – we discussed and made some updates, will continue revising to be circulated before the meeting where we will take a vote; after we approve it goes to Kingdom for approval.

## **New Business:**

- Regarding other space at church: Baron – if we have the space, we will use it. Ilaria – we could also use for A&S in a quieter area. Morton – reached out but will try again – asks for specific language to give the church (“classroom drills”)
- Johanna – did Astrid get the email about Bright Hills needing youth classes for February? They need another person who is warranted.
- Might get a group together to see Washington Revels, see Marguerite or William about group tickets, Marguerite does not think they want us in garb. Patches – Dancers may also be interested.
- Kunigunde – read aloud the details of the Storvik Novice budget to vote on. \$10 entry cost for adults, \$5 for 5-17, under 5 free. Site cost \$1,000, 75 for concessions stand worker, 350 for general supplies. Break-even point is 136 adults, 14 child attendees. Budget approved.
- Sites for events – Johanna trying to contact Cedarville State Park but they are closed for the season.
- Marguerite will discuss voice-to-text software at another meeting when we don’t have interested members calling in (audio problems).
- Contract for St. Andrews’ Episcopal Church for Monday fighter practices; same terms as this year, \$850 per quarter/65 per night. They will let us know the two weeks we cannot use the hall and we can notify them in advance. Jan 6 2020 might not be covered in our contracts – Angeline says she does not mind if it’s canceled.
- Archery equipment - Tala moved out of the Barony and does not really have room for the archery equipment in her new place or her car. Johanna says there might be room at Tommy’s in one of his sheds. Brenna says she can store it in her trailer with her SCA stuff for the winter.
- Bad check – Morton says one check for Coronation bounced, a \$15 check and \$12 bank fee for NSF. Is starting procedure to collect. At next Financial Policy meeting, we will discuss whether we want to set a rule for bounced checks.
- January meeting is weekend of 12<sup>th</sup> Night, many of us will be out of the state – Johanna proposes that we change the meeting to January 12. Voted yes.
- Grill – Kunigunde says the grill needs to be inspected; Igor said he would take a look at it. Marguerite proposes that we vote to dispose of the grill if Igor says it can’t be repaired – approved.

Meeting adjourned.

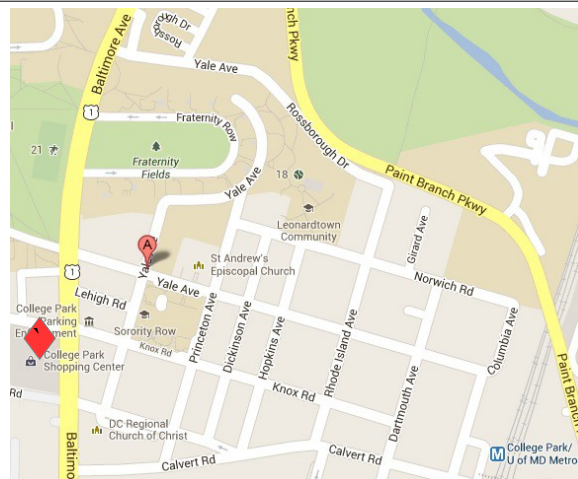

## Release Forms

Want to share something in the Drekkar? Give me legal permission to do so!

[Grant of Use Form](#): For articles, non-photograph artwork, most other contributions

[Model Release Form](#): People appearing in photographs must sign this if:

1. The image is portrait-style
2. The photograph is taken in a private space at an event (such as a personal encampment)
3. The photograph is taken at a non-public venue (such as an armor-making workshop at a home)

No model release form is needed when the photograph is taken at a public place and in a public forum

(where there is no expectation of privacy), including:

- any SCA contest or competition, merchants' row, court, class, etc.

[Photo Release Form](#): The photographer who takes a picture (of anything or anyone) must sign a release form.
